RESOLUTION TO ISSUE A POSITIVE DECLARATION

IN THE MATTER OF BRI ESTATES RESIDENTIAL SUBDIVISION

WHEREAS, the Town of Niagara received an application for subdivision approval, as amended on August 22, 2017, requesting 119 residential subdivision lots on an approximately 40 acre project site (“Project”); and

WHEREAS, the Town of Niagara Town Board (“Board”) determined that the project is an Unlisted Action; and

WHEREAS, pursuant to the State Environmental Quality Review Act (“SEQRA”) and corresponding regulations thereto, the Board declared its intent to assume the role of lead agency to coordinate environmental review of the Project; and

WHEREAS, copies of the full Part 1 Environmental Assessment Form (“EAF”) were circulated to the identified involved agencies on October 23, 2017; and

WHEREAS, no objection to the Board acting as the Lead Agency was received within 30 days of transmittal and the Board became the lead agency on November 23, 2017; and

WHEREAS, the Board has considered the full EAF part 1, 2, and 3, and the application as well as the criteria for determining significance under SEQRA as set forth under 6 NYCRR 617.7(c), and for the reasons set forth in the Positive Declaration form attached hereto and made a part hereof, the Board has determined that the Project may include the potential for at least one significant adverse environmental impact if approved and built; and

NOW THEREFORE BE IT RESOLVED:

1. The Board hereby adopts the Part 2 and Part 3 EAF as prepared by Town staff and examined by the Board, copies of which are attached hereto and made a part hereof; and
2. The consequences of this action are likely to occur in the long term and could be irreversible after construction. The project and its potential impacts are significant in magnitude and number of persons affected; and
3. The Board hereby determines that the action may result in one or more potentially significant environmental impacts and hereby adopts and issues the Positive Declaration – Notice of Intent to Prepare a Draft EIS for the reasons set forth therein, a copy of which is attached hereto and made a part hereof; and
4. Scoping of the Draft Environmental Impact Statement (DEIS) will be conducted, including an opportunity for public involvement. The applicant is directed to prepare a draft scoping document for submission to the lead agency; and
5. A DEIS will be prepared by the applicant and submitted to the lead agency for review after a Final Scoping Document is adopted; and
6. This resolution shall take effect immediately.
