JB2 Partners, LLC ("JB2") has submitted an application to the Town Board for site plan approval and area variance ("Application") to facilitate the proposed development of approximately 216 acres of land located at 8995 Lockport Road (SBL: 132.18-1-2; 146.05-1-9; 146.06-1-1; 146.06-1-2) ("Site"), in the Town of Niagara ("Town"), New York, for use as an e-commerce storage and distribution facility for consumer products ("Facility"), by a single prospective tenant ("Project"). The Facility has a footprint of approximately 650,000 square feet, and will consist of five stories, for a total floor area of approximately 3,075,950 square feet.

Under the Town of Niagara Zoning Code (the "Code"), the Site is located in the Heavy Industrial District ("HI"), which authorizes a storage and distribution facility as a permitted use, and is established to "provide[] areas within the Town of Niagara for a more extensive industrial use." The Site has been long-targeted for development and is designated a Build-Now NY Shovel Ready Certified Site by Empire State Development—a designation the Site has held since 2012.
