- Councilman Carpenter stated that Porter Rd needs a right hand turning lane onto Packard Rd., that there needs to be a turning lane for his subdivision, he feels what everyone is feeling about this project and that he would be in favor of Amazon traffic having to use Lockport Rd. instead of Packard Rd.
- Supervisor Wallace Stated Amazon is not a done deal, the town handles every project the same and that they moved the May meetings so they could have the traffic studies back.
