

WHEREAS, the effects of climate change will endanger our infrastructure, economy and livelihoods; harm our farms, orchards, and ecological communities, including native fish and wildlife populations; spread invasive species and exotic diseases; reduce drinking water supplies and recreational opportunities; and pose health threats to our citizens; and



#### AGREEMENT TERMS

#### 1. Grant of License

Niagara Storage hereby grants a license to the Town, its officers, employees, agents, contractors, and artists retained by the Town to use the entire rear northwest side of the building at 2590 Military Road in the Town for a painted mural promoting the Town.

#### 2. Terms of License Agreement

The term of this license shall commence on the Effective Date of this License Agreement and shall expire after twenty-five (25) years from the Effective Date.

#### 3. Access

Niagara Storage shall permit and afford the Town, its officers, employees, agents, contractors, and artists retained by the Town, access on foot and by vehicles to enable and allow the installation, painting, repair, maintenance, replacement, and renewal of the mural.

#### 4. Conditions of Permitted Use

Permission to use the Premises is subject to the following terms and conditions:

- a. The Town shall protect the existing improvements and fixtures on the northwest wall of the building.
- b. The use of the Premises shall not damage any self-storage facilities or pavement or otherwise disrupt or interfere with the use of the Premises.
- c. The Town shall acquire all necessary permits, if any, required for the installation of the mural and use of the Premises.
- d. The Town shall keep the Premises free of any litter or debris resulting from the installation and maintenance of the mural.

#### 5. Utilities

The Town shall be solely responsible for all utilities furnished to the Town for use of the Premises.

#### 6. Responsibility for Damage to the Premises

The Town shall be responsible for and shall indemnify Niagara Storage against any and all damage to person or property, including without limitation, the Premises, caused by the Town, its officers, employees, agents, contractors, and artists relating to the installation, repair, and maintenance of the mural.

#### 7. Maintenance, Repair and Modification of Mural

The Town shall be solely responsible for maintenance, repair, modification, and painting of the mural during the entire term of this License Agreement. In the event that the mural is damaged or defaced, the Town will promptly repair and/or restore the mural.

#### 8. Visibility of the Mural

Niagara Storage will not obstruct or impair full visibility of the mural from the public highways and roadways located along the Premises.

#### 9. Right of Entry

Throughout the term of this License Agreement, the Town shall have the right to enter the Premises during normal business hours with at least forty-eight (48) hours' notice to Niagara Storage, for any and all of the purposes needed and described in this License Agreement.

#### 10. Mural Design

The mural designer shall retain full and all copyright to the mural, including reproduction, display, and derivative rights.

#### 11. Compliance with Laws

The Town shall comply with all laws, statutes, ordinances, rules or regulations of the United States, the State of New York, County of Niagara and Town of Niagara, New York, and any department or agency thereof, including such regulations now in force or to be established pertaining to the Town's use of the Premises.

#### 12. Subletting, Assignment

The Town shall not sublet, sublicense, or assign any portion or part of this

License Agreement to any other party without the express written consent of the property owner,
which consent may be granted or withheld by the property owner, in its sole and absolute
discretion.

#### 13. Binding Agreement

This License Agreement shall be of full force and affect on any and all present and future tenants of the Premises and any and all present and future owner of the Premises during the entire term of this License Agreement. The Town may record this License Agreement in the Niagara County Clerk's Office.

#### 14. Notice

All notices herein provided to be given, or which may be given by either party to the other, shall be deemed to have been fully given and fully received when made in writing and deposited in the United States mail, certified postage prepaid, and addressed to the respective parties at the addresses as follows:
